Code of Conduct

All Archers

We all have a responsibility to promote high standards of behaviour in Archery. As an archer, we all have a big part to play. That is why Southside Archery is asking every archer to follow a code of conduct.

The Southside Archery Code of Conduct applies to all Southside Archery members when participating in or administering the sport of archery.

Expected minimum standards of behaviour and conduct

As a Southside Archery member I will:

- Respect the spirit of fair play in archery
- Adhere to Southside Archery's Rules of Shooting
- Display and promote high standards of behaviour
- Promote fair play – I won't cheat, complain or waste time
- Endeavour to ensure the sport is enjoyable for everyone
- Accept success and failure, victory or defeat with dignity
- Never engage in or tolerate public criticism of fellow archers, coaches or officials
- Respect the rights, dignity and worth of my fellow archers
- Speak to my fellow archers, coaches and volunteers with respect
- Remember we all make mistakes
- Always respect the confidentiality of other archers
- Treat other people's data as I would wish them to treat mine
- Always have the best interests of my fellow archers at heart

I will endeavour to ensure my own safety and the safety of others I will:

- Never participate when under the influence of alcohol or drugs
- Place the well-being, safety and enjoyment of each archer above everything including standards of performance
- Protect others involved in archery from verbal or physical abuse and threatening or intimidating behaviour
- Never engage in or tolerate offensive, insulting or abusive language or behaviour
- Never engage in or tolerate bullying, intimidation or harassment

- Never use or tolerate the use of social media to engage in bullying, intimidation or harassment
- Not attend or enter the archery venue if I am suffering from a contagious or infectious illness or have symptoms of one

I will abide by Southside Archery's Rules and Policies including:

- Southside Archery Rules of Shooting
- Southside Archery Safeguarding Policy
- Southside Archery Equality Policy

I take personal responsibility:

- To update Southside Archery with changes to personal information such as emergency contact details or details related to a health condition
- To inform the club about a change to my health that could affect my ability to shoot safely or could cause me to require medical treatment whilst participating in archery.

By joining Southside Archery, everyone agrees to abide by this Code of Conduct, all Southside Archery policies, rules, regulations and procedures.

Southside Archery therefore has the right to investigate and take disciplinary action, as in line with the Southside Archery Disciplinary Policy, Regulations and Procedures, against any alleged breaches of this Code of Conduct or our policies, rules, regulations and procedures, which may bring Southside Archery into disrepute.

Parent/guardian of young archers

By enrolling my child/young person in Southside Archery I agree to:

- Ensure my contact details are up to date with the secretary
- Inform the club of any conditions/illnesses affecting my child/young person which may affect their ability to participate in archery or may be exacerbated by participating in archery
